Inspector Comments: Environmental health received a complaint on 09/23/2022 stating the facility is infested with rodents, specifically the kitchen area. Complainant also stated the working conditions are unsanitary and facility is dirty.

Questioned the manager who stated they were unaware of the complaint. Per the manager, pest control services the facility every week. A pest control report was available from "Stanley Pest Control" dated on 09/15/2022, however service was for cockroaches. No rodent activity was stated on the report. Manager stated they have not seen any rodents and they deep clean the facility every night.

#### Observations:

- After thorough search of the facility, observed no rodents or rodent droppings within the facility
- Accumulation of dirt on the floors throughout the facility

Maintain the facility free of vermin. Clean and sanitize any affected areas. Clean the floors and maintain in a clean and sanitary manner to prevent vermin harborage.
