Measured sanitizer (QUAT) @ 100 ppm in both sanitizer bucket used for the back kitchen . Maintain sanitizer concentration between 200-300 ppm.

**Violation Description:** Wiping cloths used to wipe service counters, scales or other surfaces that may come into contact with food shall be used only once unless kept in clean water with sanitizer. (114135, 114185.1, 114185.3 (d-e)) Sponges shall not be used in contact with cleaned and sanitized or in-use food contact surfaces. (114135)
