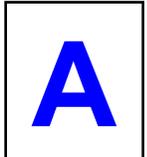

8. TIME AS A PUBLIC HEALTH CONTROL; PROCEDURES & RECORDS

POINTS 2	Compliance date not specified	Inspector Comments: When using time control, write down the discard time on the sneezeguard which is 4 hours after the food is made.
	Not In Compliance	

Violation Description: When time only, rather than time and temperature is used as a public health control, records and documentation must be maintained. Food must be marked or otherwise identified as to what time the food was removed from temperature control. (114000) Food items shall not exceed the time marked. (114000)

9. PROPER COOLING METHODS

POINTS 2	Compliance date not specified	Inspector Comments: Observed rice cooling in a deep metal mixing bowl at 140F in the walkin. Quickly cooldown potentially hazardous food from 135F to 70F in 2 hours and then 70F to 41F in 4 hours by using shallow stainless steel pans, ice baths, ice paddles, portioning, etc. Educate employees. Post the cooling handout in the kitchen.
	Not In Compliance	

Violation Description: All potentially hazardous food shall be RAPIDLY cooled from 135F to 70F, within 2 hours, and then from 70F to 41 F, within 4 hours. Cooling shall be by one or more of the following methods: in shallow containers; separating food into smaller portions; adding ice as an ingredient; using an ice bath; stirring frequently; using rapid cooling equipment; or, using containers that facilitate heat transfer. PHF is to be cooled within 4 hours to 41F if prepared from ingredients at ambient temperature. Deliveries of PHF is to be cooled to below 41F within 4 hours if received between 41F to 45F.

POINTS 1	Compliance date not specified	Inspector Comments: Observed a bowl of vegetables on the floor. Store food off the floor. Observed raw meat stored above and next too cooked foods in refrigerators. Store raw meats on the bottom shelves. Store cooked, ready to eat foods above to prevent cross contamination. Observed a container of ginger and wasabi outside of the sneezeguard. Move these foods under the sneezeguard.

Violation Description: All food shall be separated and protected from contamination. (113984 (a, b, c, d, f), 113986, 114060, 114067(a, d, e, j), 114069(a, b), 114077, 114089.1 (c), 114143 (c)) All food shall be stored, prepared, displayed or held so that it is protected from contamination.

POINTS 1	Compliance date not specified	Inspector Comments: Observed employees using dirty, deteriorated cutting boards. Discard cutting boards and use the new ones. Observed debris buildup in the cabinets, walkin freezer floor. Clean and maintain these areas.

All utensils and equipment shall be approved, installed properly, and meet applicable standards. (114130, 114130.1, 114130.2, 114130.3, 114130.4, 114130.5, 114132, 114133, 114137, 114139, 114153, 114155, 114163, 114165, 114167, 114169, 114177, 114180, 114182)

41. PLUMBING; PROPER BACKFLOW DEVICES

POINTS 1	Compliance date not specified	Inspector Comments: Repair the nonfunctioning toilet in the womens restroom.

Violation Description: The potable water supply shall be protected with a backflow or back siphonage protection device, as required by applicable plumbing codes. (114192) All plumbing and plumbing fixtures shall be installed in compliance with local plumbing ordinances, shall be maintained so as to prevent any contamination, and shall be kept clean, fully operative, and in good repair. Any hose used for conveying potable water shall be of approved materials, labeled, properly stored, and used for no other purpose. (114171, 114189.1, 114190, 114193, 114193.1, 114199, 114201, 114269)
