Inspector Comments: The purpose of this reinspection was to determine compliance regarding facility's closure due to rodent infestation.

At the time of this inspection, observed no evidences of active rodent infestation throughout this facility. Observed all floors, walls, and ceilings are maintained in clean and good condition. The owner produced a professional pest control received done on 11/1/19. Observed more than 10 empty rodent snap traps, and glue traps throughout the kitchen floors. The owner stated that additional food items were discarded during clean up are: sprinkles, chocolate, cookies, and fruits for safety purposes even though they were not contaminated. According to the owner, all affected areas were washed and sanitized with hot water at 120 F and 1/10 portion of Chlorine and water sanitizing solution.

RESULT(S):

Facility is reopened. Health permit to operate is hereby reinstated.

A supervisory review is scheduled on 11/6/19 at 10:00 am at 8575 Haven ave, suite 130, Rancho Cucamonga. The owner was informed that failure to show up to this review will result in facility closure or further legal action.

A reinspection will conducted on or after 11/11/19 to determine compliance. Continue to eliminate all vermin and any evidences of vermin infestation from this food facility. Any evidences of rodent infestation will result in facility closure. The owner was informed regarding a billable risk based inspection of \$245.00 hourly rate due to the facility closure.

Description: Reinspection conducted at this time to determine compliance from prior inspection.

Facility was reopened and grade card "A" was posted on this date. Health permit was reinstated.
