	After a complete and thorough inspection observed some of the foods on the customer self service areas to be out of temperature.		
	This facility uses time as a temperature control. Food kept out of temperature for four hours or more must be discarded at the four hour mark.		
	On this date person in charge provided time logs of all foods on the line. He stated food is discarded after four hours.
