Ensure quaternary ammonia sanitizer level is maintained between 200 ppm - 300 ppm. NOTE: -Sanitizer from dispenser on wall does not dispense proper level is quaternary ammonia sanitizer. Operator shall manually set-up sanitizer using sanitizer bottle and diluting with water to ensure sanitizer level is maintained between 200 ppm - 300 ppm for quaternary ammonia.

Violation Description: This facility is currently in violation with the food worker certification requirement for San Bernardino County, which states all food workers must obtain a valid food worker certificate within fourteen (14) days of employment (33.0410, 33.044).
