Electric fly trap observed unplugged. Maintain facility free from flies at all times. Provide approved vermin proofing method to eliminate flies. Operator was advised to discard to-go-containers contaminated by flies.  Observed live nymph and adult cockroaches throughout facility, including on floor and wall beneath front counter, at warewashing area where clean utensils and open food observed stored, and on wall at mop sink and between water heater and ice machine. Maintain facility free from cockroaches and other vermin at all times.  Gaps observed in ceiling and at side and bottom of delivery door. Food debris observed beneath equipment and in floor sink. Eliminate gaps and maintain facility free from food debris to eliminate vermin attraction.  Pest control invoice observed on site, dated 9/21/20, with invoice stating facility was treated for german cockroaches. Sticky traps observed placed beneath ice machine and front counter, with excessive live and dead cockroaches. Live cockroach observed during pest control visit, according to invoice. Pest control invoice also states recommendations were provided to manager by pest control technician.  Facility closed due to cockroach infestation.

Pooled water observed in divot in cement adjacent to floor drain located at 3-compartment sink. Remove standing water and ensure floor is in good repair.  FRP wall at mop sink observed with residue/debris. Clean walls.  Ceiling tiles above front counter, prep, and warewashing area observed with water damage. Repair/replace tiles.  Gaps observed in ceiling where water heater enters. Seal gaps.  <u>Light attached to ceiling in storage area observed not completely secured. Secure light to ceiling.</u>

**Violation Description:** The walls / ceilings shall have durable, smooth, nonabsorbent, and washable surfaces. All floor surfaces, other than the customer service areas, shall be approved, smooth, durable and made of nonabsorbent material that is easily cleanable. Approved base coving shall be provided in all areas, except customer service areas and where food is stored in original unopened containers. Food facilities shall be fully enclosed. All food facilities shall be kept clean and in good repair. (114143 (d), 114257, 114266, 114268, 114268.1, 114271, 114272) Cleaning must be an approved dustless method. (114268.1) Mats and duckboards, if used, must be removable and easily cleanable. - Four (4) or more critical violations (codes 1-23) noted during an inspection, or
- A permit suspension (closure) on your last graded inspection.
