Inspector Comments: While driving through the shopping center , observed the letter grade (C) missing from the facility front window . Upon questioning the person in charge , she stated that the letter grade fell behind the booth .The district inspector posted and tapped the letter grade back .
The letter grade card shall not be defaced, marred, camouflaged, hidden, relocated or removed. It shall be unlawful to operate a food facility unless the letter grade card is posted. Defacing, marring, camouflaging, hiding, relocating or removing the letter grade card may result in the suspension or revocation of the permit to operate and shall be punishable as specified in § 33.0112 of this [San Bernardino County] Code.

Violation Description: Handwashing signs shall be posted in each toilet room, directing attention to the need to thoroughly wash hands after using the restroom (113953.5) (b) No smoking signs shall be posted in food preparation, food storage, warewashing, and utensil storage areas (113978). (c) Consumers shall be notified that clean tableware is to be used when they return to self-service areas such as salad bars and buffets. (d) Any food facility constructed before January 1, 2004 without public toilet facilities, shall prominently post a sign within the food facility in a public area stating that toilet facilities are not provided (113725.1, 114381 (e)). A sign shall be posted stating that a copy of the most recent routine inspection report is available upon request. (113725.1) Permit shall be posted in conspicuous location. (114381(e)) Letter Grade Placecard shall be properly posted. SBCC 33.1406
