Inspector Comments: PURPOSE:

The purpose of this inspection is to verify compliance with items noted during the routine inspection that was conducted on 3/12/2019. It was noted during the routine inspection that the drainage pipping for the three compartment sink was detached allowing sewage to spill onto the floor.

OBSERVATION:

On this date the pipping was observed detached from the wall allowing sewage to spill onto the floor. The cook was able to reattach the pipe and stop the leak.

OUTCOME:

Repair this pipe to prevent sewage from spilling onto the floor and ensure that sewage is disposed of properly. A follow up inspection will be conducted after 3/25/2019 to observe compliance. The next inspection will be billable at a rate of \$122.50 per half hour with a half hour minimum. Failure to comply will result in further billable re-inspections or possible closure.

Description: Reinspection conducted at this time to determine compliance from prior inspection.

16C022 Sewage and wastewater properly disposed
