

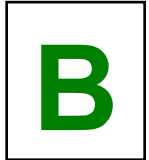

Employee was educated that hand washing is to only be done in the hand washing sink. Discontinue this practice. Ensure all employees are conducting hand washing in the hand washing sinks only. If hand washing is conducted in any other sink, the sink shall be washed, rinsed and sanitized.

Violation Description: Handwashing soap and towels or drying device shall be provided in dispensers; dispensers shall be maintained in good repair. (113953.2) Adequate facilities shall be provided for hand washing. (113953, 113953.1, 114067(f)). Handwashing sink is not separated from a warewashing sink by a 6 inch high metal splashguard or 24 inch separation. (113953) Handwashing sinks shall not be obstructed, inaccessible, used improperly or kept unclean. (113953.1)

Inspector Comments: Observed the following unapproved thawing methods:

1) a large stainless steel bowl strainer with whole raw shrimp was thawing in the preparation sink with minimal running water. Upon questioning an employee advised the shrimp had been thawing for 1 hour. The temperature of the shrimp measured at 70 F.

2) two (2) large plastic containers containing thawed plastic vacuum sealed ribs on the floor underneath the food preparation table across from the hand wash sink. The temperature of the ribs measured 42 F. Upon questioning an employee stated they had been thawing under the preparation table for 1 hour.

3) one large sheet pan of frozen ribs and one large sheet pan of frozen chicken breasts were plastic wrapped and thawing on a preparation table adjacent to the mop sink. Ribs and chicken measured at 40 F.

Discontinue this practice. Ensure foods are thawed using the following approved methods:

- under refrigeration
- completely submerged in cold (no higher than 70F), running water for less than 2 hours
- in a microwave
- during the cooking process.

Corrected on site. Employee relocated all the meat products to the walk in refrigeration unit.

Violation Description: Food shall be thawed under refrigeration; completely submerged under cold running water (less than 70F) of sufficient velocity to flush loose particles for less than 2 hours; in microwave oven; or during the cooking process. (114018, 114020, 114020.1)

Violation Description: Exhaust hoods shall be provided to remove toxic gases, heat, grease, vapors and smoke and be approved by the local building department. Canopy-type hoods shall extend 6" beyond all cooking equipment. All areas shall have sufficient ventilation to facilitate proper food storage. Toilet rooms shall be vented to the outside air by a screened openable window, an air shaft, or a light-switch activated exhaust fan, consistent with local building codes. Repair/replace urinal to facilitate flushing and maintain in an functioning state.

Violation Description: Toilet facilities shall be maintained clean, sanitary and in good repair for use by employees and patrons. Toilet rooms shall be separated by a well-fitting, self-closing door. Toilet tissue shall be provided in a permanently installed dispenser at each toilet. Upon questioning an employee stated the boxes are for to go orders. Discontinue this practice. Ensure the facility is free of items that cause clutter to prevent vermin nesting.

Repair/replace missing and unattached pieces of flooring and base coving. Clean and maintain clean the flooring underneath equipment throughout kitchen.

Violation Description: The walls / ceilings shall have durable, smooth, nonabsorbent, and washable surfaces. All floor surfaces, other than the customer service areas, shall be approved, smooth, durable and made of nonabsorbent material that is easily cleanable. Approved base coving shall be provided in all areas, except customer service areas and where food is stored in original unopened containers. Food facilities shall be fully enclosed. All food facilities shall be kept clean and in good repair. (114143 (d), 114257, 114266, 114268, 114268.1, 114271, 114272) Cleaning must be an approved dustless method. (114268.1) Mats and duckboards, if used, must be removable and easily cleanable.
