 Maintain chlorine sanitizer buckets at 100-200ppm. Ensure to change buckets every four hours or as necessary.
 Corrected on site. Sanitizer brought to 200ppm.
 Observed black mold-like substance in ice machine.
 Clean and maintain food contact surfaces throughout facility regularly.
 Observed tubes/pipes from water machine inside the ice at beverage station. Observed ice being used for customer beverages.
 Discontinue use of ice for customer beverages unless pipes are moved or a divider is provided.

Violation Description: All food contact surfaces of utensils and equipment shall be clean and sanitized. (113984(e), 114097, 114099.1, 114099.4, 114099.6, 114101 (b-d), 114105, 114109, 114111, 114113, 114115 (a, b, d), 114117, 114125(b), 114135, 114141)

Inspector Comments: Observed beef noodle soup on turned off stove at 126F. Cook stated that the soup was made 3 hours prior and he was waiting to put it at the steam table for dinner.
 Corrected on site. Soup brought to 165F on stove and held until being placed on the steam table.
 Maintain hot holding foods at 135F and above.

Violation Description: Potentially hazardous foods shall be held at or below 41F or at or above 135F. (113996, 113998, 114037, 114343(a))

Violation Description: Food shall be stored in approved containers and labeled as to contents. Food shall be stored at least 6" above the floor on approved shelving in an approved location to prevent possible contamination. (114047, 114049, 114051, 114053, 114055, 114067(h), 14069 (b))

Observed chlorine levels at above 200 ppm in sanitizer bucket at beverage station. Ensure that chlorine levels are 100 ppm in sanitizer buckets, and do not exceed 200 ppm.

Violation Description: Wiping cloths used to wipe service counters, scales or other surfaces that may come into contact with food shall be used only once unless kept in clean water with sanitizer. (114135, 114185.1, 114185.3 (d-e)) Sponges shall not be used in contact with cleaned and sanitized or in-use food contact surfaces. (114135)

POINTS 1	Compliance date not specified	Inspector Comments: Observed pipes in floor sink at ice machine and outside of the walk-in. Maintain a one inch air gap at all floor sinks throughout facility.

Violation Description: The potable water supply shall be protected with a backflow or back siphonage protection device, as required by applicable plumbing codes. (114192) All plumbing and plumbing fixtures shall be installed in compliance with local plumbing ordinances, shall be maintained so as to prevent any contamination, and shall be kept clean, fully operative, and in good repair. Any hose used for conveying potable water shall be of approved materials, labeled, properly stored, and used for no other purpose. (114171, 114189.1, 114190, 114193, 114193.1, 114199, 114201, 114269)
