Per owner, this PHF was cooked and stored on this table two (2) hours prior to the inspection. The owner stated this PHF is held at room temperature up to four (4) hours and discarded. Written procedures were not observed.</p> <p>Corrected on site. The owner was instructed to discard the PHF after four hours.
