Person in charge states that the circuit breaker continually turns off and it is left off until hot water is needed. A minimum hot water temperature of 120 degrees must be supplied at all times. Do not conduct any warewashing of utensils until a minimum of 100 degree water is supplied to the 3 compartment sink.

Violation Description: Exhaust hoods shall be provided to remove toxic gases, heat, grease, vapors and smoke and be approved by the local building department. Canopy-type hoods shall extend 6" beyond all cooking equipment. All areas shall have sufficient ventilation to facilitate proper food storage. Toilet rooms shall be vented to the outside air by a screened openable window, an air shaft, or a light-switch activated exhaust fan, consistent with local building codes. (114149, 114149.1) Adequate lighting shall be provided in all areas to facilitate cleaning and inspection. Light fixtures in areas where open food is stored, served, prepared, and where utensils are washed shall be of shatterproof construction or protected with light shields. (114149.2, 114149.3, 114252, 114252.1)

41. PLUMBING; PROPER BACKFLOW DEVICES

Provide a minimum 1" air gap between drain pipes and floor sink grates.

Violation Description: The potable water supply shall be protected with a backflow or back siphonage protection device, as required by applicable plumbing codes. (114192) All plumbing and plumbing fixtures shall be installed in compliance with local plumbing ordinances, shall be maintained so as to prevent any contamination, and shall be kept clean, fully operative, and in good repair. Any hose used for conveying potable water shall be of approved materials, labeled, properly stored, and used for no other purpose. IMPORTANT: Risk Based Inspection Frequency

- A permit suspension (closure) on your last graded inspection.

Notice of Closure sign posted. Do not remove sign or open facility without an approval from Environmental Health.

Grade card will be posted upon reinspection and permit reinstatement.

Please note that it is the responsibility of the operator to close facility whenever a significant threat to public health has occurred.

Continual failure of the water heater and hot water supply may result in charged reinspections and/or further legal action such as the revocation of the health permit.
