**Inspector Comments:** Reinspection conducted this date as per the inspection report dated 8/30/2019 to observe compliance for the rodent infestation in the kitchen.

Observations:

Facility remains in the same condition as observed in the inspection conducted on 8/30/2019: "Old and what appears to be fresh rodent droppings observed under the warewash machine, behind and beside the two-door chest freezer, the upright reach in refrigerator, under and behind the chest freezer, on the shelves that stores disposable cups and lids, packets of sugar and tea, and under and behind all of the unused kitchen stoves, reach in refrigerators, steam tables".

A reinspection will be conducted on Thursday, September 5, 2019. Any and all future reinspections conducted will be billed at the current hourly rate.

**Description:** Reinspection conducted at this time to determine compliance from prior inspection.
