**Inspector Comments:** Complaint stated they observed employee packing rice and noodles into bowls without gloves or utensils.

During complaint investigation, observed the following:

- Tongs available and used for noodles in front serving area.
- Spoon available for rice in front serving area.
- Owner states they always use either gloves or a utensil when serving food and they wash their hands before serving.

Suggested to employees they could wear gloves in addition to using utensils when serving food.

Complaint closed.
