**Inspector Comments:** A reinspection has been conducted on this date to follow-up on the status of the facility's submission of their request for rescore form.

During the facility's routine inspection, they received a letter grade "B". During their elevated risk inspection, the facility was downgraded to a letter grade "C". The facility must submit their request for rescore form within thirty (30) days after their inspection in which they received a letter grade "C" to our department. Per operator, the facility has also undergone a transfer of ownership and was provided the transfer of ownership form during their elevated risk inspection conducted on 2/25/2019. Per operator, the operator paid a visit in person to the main office of the Department of Public Health Environmental Health Services in San Bernardino to submit the transfer of ownership form on 3/22/2019. This office visit was verified by in-office staff and the transfer of ownership is currently on hold due to a request for additional information.

Upon consultation with a supervisor, the facility may be pending an appointment for a supervisor review at the San Bernardino office Department of Public Health Environmental Health Services. The facility operator will be contacted with further information.

**Inspector Comments:** Observed missing letter grade card C. Letter grade C was posted at the cash register during the elevated risk routine inspection.

Noncompliance to post the letter grade in a conspicuous location will result in a billable charged at a rate of \$245 per hour with a minimum of 30 minutes at \$122.50.

Letter grade must be posted in a conspicuous location at all times.

**Violation Description:** Handwashing signs shall be posted in each toilet room, directing attention to the need to thoroughly wash hands after using the restroom (113953.5) (b) No smoking signs shall be posted in food preparation, food storage, warewashing, and utensil storage areas (113978). (c) Consumers shall be notified that clean tableware is to be used when they return to self-service areas such as salad bars and buffets. (d) Any food facility constructed before January 1, 2004 without public toilet facilities, shall prominently post a sign within the food facility in a public area stating that toilet facilities are not provided (113725.1, 114381 (e)). A sign shall be posted stating that a copy of the most recent routine inspection report is available upon request. (113725.1) Permit shall be posted in conspicuous location. (114381(e)) Letter Grade Placecard shall be properly posted. SBCC 33.1406

#### Overall Inspection Comments

The letter grade "C" was observed to be non-posted at the beginning of inspection. Facility was observed to be open to the public and in full operation.

The letter grade "C" was reposted on this date at the cashier station.
