POINTS 4	Compliance date not specified Complied on 4/2/2015 Violation Reference -	Inspector Comments: Observed the cook washing his hands within 2-5 seconds . Food workers shall wash their hands with warm water (100F) and soap for at least 15 seconds. Observed the food workers at the cook line changing gloves after handling raw food without proper hand washing then proceed to handle ready to eat food . Food workers shall wash their hands before placing new gloves on and between changing tasks .

Violation Description: Employees are required to wash their hands: before beginning work; before handling food / equipment / utensils; as often as necessary, during food preparation, to remove soil and contamination; when switching from working with raw to ready to eat foods, after touching body parts; after using toilet room; or any time when contamination may occur. Gloves shall be worn if an employee has cuts, wounds, fake nails, nail polish, and/or rashes. Gloves are to be used for no more than one task. Employees are not to wrap or package leftover food using bare hands or unclean utensils. Hand sanitizers may be used after proper hand washing. Employees handling food must have fingernails that are trimmed, cleanable, and smooth. (113952, 113953.3, 113953.4, 113961, 113968, 113973 (b-f))

POINTS 2	Compliance date not specified Not In Compliance Violation Reference - HSC - 114057	Inspector Comments: Observed the food workers not in compliance with the variance regarding placing double gloves when cracking eggs and handling raw food(beef patties). Observed the food worker placing blue gloves without washing his hands , crack eggs , remove gloves and proceed to cook the food. Facility operator shall be in compliance and follow the variance at all times.

Violation Description: HACCP Plan is a written document that delineates the formal procedures developed for safe food handling approved by the National Advisory Committee on Microbiological Criteria for Foods (114419). A written document approving a deviation from standard health code requirements shall be maintained at the food facility (114057, 114057.1). Food facility operator must submit for an HACCP approval or follow an approved HAACP plan.

40. WIPING CLOTHS: PROPERLY USED AND STORED

Violation Description: Wiping cloths used to wipe service counters, scales or other surfaces that may come into contact with food shall be used only once unless kept in clean water with sanitizer. (114135, 114185.1, 114185.3 (d-e)) Sponges shall not be used in contact with cleaned and sanitized or in-use food contact surfaces. (114135)

41. PLUMBING; PROPER BACKFLOW DEVICES

POINTS 1	Compliance date not specified Not In Compliance Violation Reference - HSC - 114171, 114189.1	Inspector Comments: Observed the copper drain pipes underneath the 3 compartment sink and the mechanical dish washer resting inside the floor sinks . Provide one inch gap or twice the diameter of the pipe whichever greater above the rim of the floor sink.

Violation Description: The potable water supply shall be protected with a backflow or back siphonage protection device, as required by applicable plumbing codes. (114192) All plumbing and plumbing fixtures shall be installed in compliance with local plumbing ordinances, shall be maintained so as to prevent any contamination, and shall be kept clean, fully operative, and in good repair. Any hose used for conveying potable water shall be of approved materials, labeled, properly stored, and used for no other purpose. (114171, 114189.1, 114190, 114193, 114193.1, 114199, 114201, 114269)
