Inspector Comments: 1. Observed approximately seventeen (17) rodent droppings inside a cabinet underneath Bunn coffe machine. Note: Observed six mouse traps inside the cabinet.

2. Observed one rodent dropping behind sunglass rack in customer service area.

3. Observed one dead cockroach-like insect on floor behind ATM machine.

Note: Per assistant manager, the facility has been frequently getting serviced by professional pest control services. The manager stated, they found a possible entry area at roof and the area has been sealed. The manager stated he is unable to access invoices from the pest control service.

Remove vermin from the facility. Clean and sanitize the affected areas.

A reinspection will be conducted on 11/30/2021 to determine compliance. Failure to comply may result at permit suspension or billable re-inspection at an hourly rate of \$245 with 30-minute minimum.

Violation Description: Food facility shall be kept free of vermin: rodents (rats, mice), cockroaches, flies. (114259.1, 114259.4, 114259.5) Live animals are not allowed in a food facility unless, food employees with service animals may handle or care for their service animal if they wash their hands as required or persons who are licensed pursuant to Chapter 11.5 of Division 3 of the Business and Professions Code. (114259.4, 114259.5)

Inspector Comments: Observed several cardboards being used to line beverages, including Redbull and water in walk-in refrigerator.

Do not use cardboards to line beverages. Provide approved equipment to line beverages and food.

Violation Description: All clean and soiled linen shall be properly stored; non-food items shall be stored and displayed separate from food and food-contact surfaces. (114185.3 - 114185.4) Utensils and equipment shall be handled and stored so as to be protected from contamination. (114074 - 114075, 114081, 114119, 114121, 114161, 114178, 114179, 114083, 114185, 114185.2, 114185.5) Pressurized cylinders must be securely fastened to a rigid structure. (114172)

IMPORTANT: Risk Based Inspection Frequency

- Repeated "four (4) point violation Risk Factor" (critical violation codes 1-23) on the last two inspections, or
- Four (4) or more critical violations (codes 1-23) noted during an inspection, or
- A permit suspension (closure) on your last graded inspection.
