As per complainant: Complainant stated that they saw mice at facility.

Upon entering facility, the manager was made aware of the nature of this complaint.

Interview:

Manager stated that facility has not experienced rodent infestation. Manager provided pest control receipts. The most recent pest control service receipt found was from 4-16-19. According to manager, pest control service is conducted every 30 days.

Observation/Finding(s):

- Evidence of rodent infestation.
- Rodent droppings on floor below soda syrups.
- Rodent droppings on 2 plastic bags filled with about 30 hamburger buns.
- Bag of hamburger buns with holes (gnaw marks).

Conclusion:

Facility closure due to evidence of rodent infestation. Take the necessary steps to eliminate all rodent evidence from facility. Clean and sanitize all affected areas.

Any food is adulterated if it bears or contains any poisonous or deleterious substance that may render it impure or injurious to health.
