

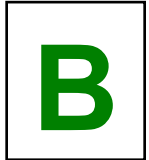

Inspector Comments: Due to this facility unable to provide hot water at all sinks, the permit is suspended. Cease the operation immediately. Please contact the Division of Environmental Health after this critical violation is corrected at 1 800-442-2283 A notice of closure sign was posted at the entrance of the facility.

Violation Description: If an imminent health hazard is found, an enforcement officer may temporarily suspend the permit and order the food facility immediately closed. (114409, 114405)

5. HANDS CLEAN AND PROPERLY WASHED; GLOVES USED PROPERLY MAJOR

Inspector Comments: 1. Observed operator walking to front meat display refrigerator area and placing raw meat directly on scale. Then, the operator grabbed red plastic roller, detached plastic bag and placing the meat inside the bag. Then, the operator grabbed exterior part of thank you bag and placed the red bag of raw meat inside the bag. The operator proceeded to put sticker on pink paper and the customer picked up the pink paper to pay for it at the front office area.

2. Observed the same operator slicing raw meat on the meat slicer. Then, the operator grabbed thank you bag and directly placed the plastic bag on the meat slicer, where he just sliced the raw meat. Then, the operator proceeded to put the raw meat inside the plastic bag.

Discontinue this practice. Ensure hands are properly washed when switching task from handling raw meat to other tasks, such as grabbing plastic bag and placing sticker on the paper.

Corrected on site. The operator and manager were educated as to cross-contamination and handwashing. The operator sanitized the scale with sanitizer. The operator was instructed to wash his hands.

Violation Description: Employees are required to wash their hands: before beginning work; before handling food / equipment / utensils; as often as necessary, during food preparation, to remove soil and contamination; when switching from working with raw to ready to eat foods, after touching body parts; after using toilet room; or any time when contamination may occur. Gloves shall be worn if an employee has cuts, wounds, fake nails, nail polish, and/or rashes. Gloves are to be used for no more than one task. Employees are not to wrap or package leftover food using bare hands or unclean utensils. Hand sanitizers may be used after proper hand washing. Employees handling food must have fingernails that are trimmed, cleanable, and smooth. (113952, 113953.3, 113953.4, 113961, 113968, 113973 (b-f))

21. HOT AND COLD WATER AVAILABLE MAJOR

Inspector Comments: 1. Observed hot water unable to be supplied at the handwashing sink due to hot water pedal in disrepair adjacent to meat display refrigerator.

2. Measured following maximum water temperatures:

- 1) Front 3-compartment sink at 83 F
2) Back 3-compartment sink at 83.1 F
3) Handwashing sink at men's restroom at 84.7 F
4) Handwashing sink at women's restroom at 84.5 F
5) Mop sink at 94.8 F

Ensure a minimum of 100 F water is supplied at all handwashing sinks and warewashing sink. Ensure a minimum of 120 F water is supplied at the mop sink and preparation sink.

The permit is suspended due to lack of hot water in the facility.

Violation Description: An adequate, protected, pressurized, potable supply of hot water and cold water shall be provided at all times. (113953(c), 114099.2(b) 114101(a), 114189, 114192, 114192.1, 114195)

Violation Description: Exhaust hoods shall be provided to remove toxic gases, heat, grease, vapors and smoke and be approved by the local building department. Canopy-type hoods shall extend 6" beyond all cooking equipment. All areas shall have sufficient ventilation to facilitate proper food storage. Toilet rooms shall be vented to the outside air by a screened openable window, an air shaft, or a light-switch activated exhaust fan, consistent with local building codes. (114149, 114149.1) Adequate lighting shall be provided in all areas to facilitate cleaning and inspection. Light fixtures in areas where open food is stored, served, prepared, and where utensils are washed shall be of shatterproof construction or protected with light shields. (114149.2, 114149.3, 114252, 114252.1)

Ensure the air gap between the drain pipe and floor sink is a minimum of one inch or twice the diameter of pipe.

Violation Description: The potable water supply shall be protected with a backflow or back siphonage protection device, as required by applicable plumbing codes. (114192) All plumbing and plumbing fixtures shall be installed in compliance with local plumbing ordinances, shall be maintained so as to prevent any contamination, and shall be kept clean, fully operative, and in good repair. Any hose used for conveying potable water shall be of approved materials, labeled, properly stored, and used for no other purpose. Violation Description: The premises of each food facility shall be kept clean and free of litter and rubbish; all clean and soiled linen shall be properly stored; non-food items shall be stored and displayed separate from food and food-contact surfaces; the facility shall be kept vermin proof. (114279(a)) First aid supplies must have a legible manufacturer's label and stored in a kit or container that is located to prevent contamination. Observed ceiling peeling throughout the facility, including above front 3-compartment sink. Ensure all walls and ceilings have durable, smooth, nonabsorbent, and washable surfaces.

Violation Description: The walls / ceilings shall have durable, smooth, nonabsorbent, and washable surfaces. All floor surfaces, other than the customer service areas, shall be approved, smooth, durable and made of nonabsorbent material that is easily cleanable. Approved base coving shall be provided in all areas, except customer service areas and where food is stored in original unopened containers. Food facilities shall be fully enclosed. All food facilities shall be kept clean and in good repair. (114143 (d), 114257, 114266, 114268, 114268.1, 114271, 114272) Cleaning must be an approved dustless method. (114268.1) Mats and duckboards, if used, must be removable and easily cleanable. (114272) Open-air barbecues or wood-burning ovens floor surfaces must extend a minimum of five feet and be impervious or easily cleanable. (114143(d))
