Inspector Comments: Observed no staff member has a Managers Certificate at this time; The food facility must have at least one (1) owner or employee who has passed an approved and accredited [ANSI] food safety certification examination within 60 days of commencing operation, changes ownership, or no longer has a certified owner or employee.

Violation Description: All food employees shall have adequate knowledge of and be trained in food safety as it relates to their assigned duties. (113947) Food facilities that prepare, handle or serve non-prepackaged potentially hazardous food, shall have an employee who has passed an approved food safety certification examination. (113947-113947.1)

Inspector Comments: Observed the handwashing sink has a bucket in it; A handwashing facility shall be clean, unobstructed, and accessible at all times for employee use.

Violation Description: Handwashing soap and towels or drying device shall be provided in dispensers; dispensers shall be maintained in good repair. (113953.2) Adequate facilities shall be provided for hand washing. (113953, 113953.1, 114067(f)). Handwashing sink is not separated from a warewashing sink by a 6 inch high metal splashguard or 24 inch separation. (113953) Handwashing sinks shall not be obstructed, inaccessible, used improperly or kept unclean. (113953.1)

Inspector Comments: Observed a cockroach nymph in the storage area; The premises of each food facility shall be kept free of vermin.

Violation Description: Food facility shall be kept free of vermin: rodents (rats, mice), cockroaches, flies. (114259.1, 114259.4, 114259.5) Live animals are not allowed in a food facility unless, food employees with service animals may handle or care for their service animal if they wash their hands as required or persons who are licensed pursuant to Chapter 11.5 of Division 3 of the Business and Professions Code. (114259.4, 114259.5)

Inspector Comments: Observed the line equipment is greasy, hard to clean areas covered with food splash; Nonfood-contact surfaces of equipment shall be kept free of an accumulation of grease and food debris.

Inspector Comments: Observed some of the pots are too big for the existing 2-Compartment warewashing sink; Utensils must be able to be submerged for cleaning.

Violation Description: Food facilities that prepare food shall be equipped with warewashing facilities. Testing equipment and materials shall be provided to measure the applicable sanitization method. (114067(f,g), 114099, 114099.3, 114099.5, 114101(a), 114101.1, 114101.2, 114103, 114107, 114125) A thermometer must be readily available to monitor the temperature of the water at the warewashing sink. A warewashing sink used to wash wiping cloths, wash produce, or thaw food must be cleaned and sanitized before and after each use.
