Observed employee dispatching customers' orders and handling money. Observed the same employee switch stations and started slicing pizza and preparing pizza boxes without washing hands. Ensure that after changing tasks/switching station; employees wash hands properly and thoroughly. Observed employee touch face and without washing hands switched to food prep/food contact duties. Ensure that after changing tasks employees wash hands properly.

Violation Description: Employees are required to wash their hands: before beginning work; before handling food / equipment / utensils; as often as necessary, during food preparation, to remove soil and contamination; when switching from working with raw to ready to eat foods, after touching body parts; after using toilet room; or any time when contamination may occur. Gloves shall be worn if an employee has cuts, wounds, fake nails, nail polish, and/or rashes. Gloves are to be used for no more than one task. Employees are not to wrap or package leftover food using bare hands or unclean utensils. Hand sanitizers may be used after proper hand washing. Employees handling food must have fingernails that are trimmed, cleanable, and smooth. (113952, 113953.3, 113953.4, 113961, 113968, 113973 (b-f))
