Clean equipment and utensils are not stored covered or inverted such that they are self-draining. Ensure all clean equipment is stored such that they are able to self drain.

**Violation Description:** All clean and soiled linen shall be properly stored; non-food items shall be stored and displayed separate from food and food-contact surfaces. (114185.3 - 114185.4) Utensils and equipment shall be handled and stored so as to be protected from contamination. (114074 - 114075, 114081, 114119, 114121, 114161, 114178, 114179, 114083, 114185, 114185.2, 114185.5) Pressurized cylinders must be securely fastened to a rigid structure. (114172)

**40. WIPING CLOTHS: PROPERLY USED AND STORED**

**Violation Description:** Wiping cloths used to wipe service counters, scales or other surfaces that may come into contact with food shall be used only once unless kept in clean water with sanitizer. (114135, 114185.1, 114185.3 (d-e)) Sponges shall not be used in contact with cleaned and sanitized or in-use food contact surfaces. (114135)

**42. GARBAGE AND REFUSE PROPERLY DISPOSED; FACILITIES MAINTAINED**

<b>POINTS</b> <b>1</b>	Compliance date not specified Not In Compliance Violation Reference - HSC - 114244, 114245	<b>Inspector Comments:</b> Observed a large amount of excess clutter and trash accumulated in the refuse facility areas. Observed various pieces of empty cardboard boxes, empty cans, and various pieces trash on the floor. The refuse facility area is cluttered to the extent that the floor cannot be cleaned, safely entered or seen.  Ensure refuse area is cleaned and maintained by not allowing floor to become cluttered with excess trash, debris and broken equipment.  This is a continuous violation. Inspector will inspect at a later date to ensure area is maintained.

**Violation Description:** All food waste and rubbish shall be kept in leak proof and rodent proof containers. Containers shall be covered at all times. All waste must be removed and disposed of as frequently as necessary to prevent a nuisance. The exterior premises of each food facility shall be kept clean and free of litter and rubbish.
