Inspector Comments: Complaint stated customer became ill with diarrhea after eating pre-packaged, non-loaf white bread.

Per manager at time of inspection:

No other complaints regarding bread have been received. No employees have been ill nor has facility experienced any food processing failure such as refrigerator problems, water or power outages, hot water heater failure, and waste water overflow within food preparation area nor were there any unusual events that occurred. Supplier of bakery items have not changed and ingredients in bread have not been modified.

-Bread is not made at facility. It is received frozen in dough form from distributor.

-Frozen bread is delivered approximately once every 2-3 days.

-Observed one baking tray lined with wax paper and red bean debris stored on top of boxes in inventory warehouse at rear of store.

-Per manager, frozen breads are removed from packaging and placed in baking sheets in bakery walk-in freezer at warehouse before taken to proofer and then baked. Observed no prep table for employees to handle breads. Discontinue practice. Ensure all preparation occurs at bakery kitchen with access to a hand washing sink. Employees must wash hands prior to handling open foods after performing activities that contaminate hands (such as touching refrigerator door handles).

-All sliced loaf breads are discarded prior to expiration date and baked, single wrapped and un-wrapped, non-potentially hazardous breads in display cases are discarded at the end of the day.

Description: A foodborne illness complaint report has been received by Environmental Health.

Inspector Comments: Observed frozen fish balls available for customer self service without lids or any method to prevent possible cross contamination. Ensure food is stored, prepared, displayed or held so that it is protected from cross contamination (i.e. sneeze guards, lids, display cases, dispensers, labeled containers)

Violation Description: All food shall be separated and protected from contamination. (113984 (a, b, c, d, f), 113986, 114060, 114067(a, d, e, j), 114069(a, b), 114077, 114089.1 (c), 114143 (c)) All food shall be stored, prepared, displayed or held so that it is protected from contamination.
