

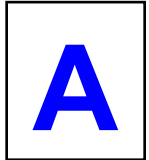

POINTS 2	Compliance date not specified Not In Compliance	Inspector Comments: Observed multiple flies inside the facility.
	Violation Reference - HSC - 114259.1, 114259.4, 11425	Ensure the facility is free of flies. Recommend routine fly control monitoring and prevention practices. NOTE: Flies that contact food or food-contact surfaces shall be discarded and cleaned and sanitized respectively.

Violation Description: Food facility shall be kept free of vermin: rodents (rats, mice), cockroaches, flies. (114259.1, 114259.4, 114259.5) Live animals are not allowed in a food facility unless, food employees with service animals may handle or care for their service animal if they wash their hands as required or persons who are licensed pursuant to Chapter 11.5 of Division 3 of the Business and Professions Code. (114259.4, 114259.5)

POINTS 1	Compliance date not specified Not In Compliance	Inspector Comments: Observed food debris dried to the surface of the cutting blade on can opener.
	Violation Reference - HSC - 114074, 114081, 114119	Clean and sanitize the can opener and ensure equipment/utensils are stored clean prior to re use.

Violation Description: All clean and soiled linen shall be properly stored; non-food items shall be stored and displayed separate from food and food-contact surfaces. (114185.3 - 114185.4) Utensils and equipment shall be handled and stored so as to be protected from contamination. (114074 - 114075, 114081, 114119, 114121, 114161, 114178, 114179, 114083, 114185, 114185.2, 114185.5) Pressurized cylinders must be securely fastened to a rigid structure. (114172)

IMPORTANT: Risk Based Inspection Frequency

Food facilities that pose a higher risk level for causing foodborne illness will be subject to an additional inspection, to be billed at the hourly rate as provided in the San Bernardino County Code [Schedule of Fees](#). Facilities that received one or more of the following will be elevated to a high risk tier:

- A score letter of "C" or lower on one of the last two graded inspections,
- A score letter of "B" on two of the last three graded inspections,
- Repeated "four (4) point violation Risk Factor" (critical violation codes 1-23) on the last two inspections, or
- Four (4) or more critical violations (codes 1-23) noted during an inspection, or
