Inspector Comments: The reason of this visit is to verify if critical violation that caused the Health permit suspension last 8/26/2016 which is vermin infestation being addressed and corrected.

At this date, observed several live nymph cockroach underneath 3 -compartment sink, under food storage shelves and under food preparation sink. Health permit is still suspended and food facility remained close.

Completely eliminate cockroach and all evidence of cockroach in the facility.

Violation Description: Violation(s) observed pose an immediate threat to public health and safety and the health permit to operate is hereby suspended and ordered closed until the listed violation(s) have been corrected and verified by DEHS. Facility is to remain closed until permission from DEHS is given. Contact your inspector at your local office to schedule a reinspection to reinstate the health permit. Posted closed, do not move, hide, or remove sign.
