Employee dipped the cutting board and knife in "Quat" sanitizer for less than 1 minute. Ensure to follow proper ware washing procedures of washing in water and soap solution that measures at 100F, rinse, and sanitize in a minimum of 200 ppm "Quat" sanitizer or a minimum of 100 ppm when using chlorine sanitizer.

Ensure all wet wiping cloths are stored in sanitizer buckets with a minimum concentration of 200 ppm quat or a minimum concentration of 100 ppm of chlorine. ----- Measured the wet wiping sanitation bucket located under the tortilla warming station at a Quat concentration of 150 ppm. Ensure to keep all sanitizer concentrations at a minimum of 200 ppm when using quat or a minimum of 100 ppm when using chlorine.

Violation Description: Wiping cloths used to wipe service counters, scales or other surfaces that may come into contact with food shall be used only once unless kept in clean water with sanitizer. (114135, 114185.1, 114185.3 (d-e)) Sponges shall not be used in contact with cleaned and sanitized or in-use food contact surfaces. (114135)
