POINTS 2	Compliance date not specified	Inspector Comments: Soap was added to all wall mounted dispensers. Maintain soap and paper towels in operable wall mounted dispensers at hand wash sinks.

Violation Description: Handwashing soap and towels or drying device shall be provided in dispensers; dispensers shall be maintained in good repair. (113953.2) Adequate facilities shall be provided for hand washing. (113953, 113953.1, 114067(f)). Handwashing sink is not separated from a warewashing sink by a 6 inch high metal splashguard or 24 inch separation. (113953) Handwashing sinks shall not be obstructed, inaccessible, used improperly or kept unclean. (113953.1)

7. PROPER HOT AND COLD HOLDING TEMPERATURES **⚠ CRITICAL ⚠**

POINTS 4	Compliance date not specified	Inspector Comments: Hot drinks were added to reach in cooler, the milk stored in it heated up. to 51°F. Chill hot drinks in an ice bath prior to adding to cooler. Cooked items, shrimp were added directly to well on preparation table. This practice must be discontinued. Cool cooked items to 41°F or less prior to placing into preparation table. The well is only capable of holding at 41°F or less.

(114185.3 - 114185.4) Utensils and equipment shall be handled and stored so as to be protected from contamination. (114074 - 114075, 114081, 114119, 114121, 114161, 114178, 114179, 114083, 114185, 114185.2, 114185.5) Pressurized cylinders must be securely fastened to a rigid structure. (114172)
