- Several rodent droppings on and around the boxes of cereal
- Two (2) rodent droppings on cans of soup
- Two (2) rodent droppings in the box containing chow mein packages

Upon questioning, the manager was unable to provide pest control invoices on this date and stated that they believed that the most recent pest control service was conducted on Friday, 6/4/21.

The permit was suspended on this date due to an active rodent infestation. A follow up inspection is required prior to reopening the food and beverage portion of the facility.

The manager and food workers removed visible rodent droppings and began cleaning and sanitizing the affected areas.

The food and beverage areas of the facility were observed blocked off from customer access.

Description: Billable re-reinspection conducted at this time to determine compliance from prior reinspection.

Call Environmental Health Services at (800) 442-2283 for a follow up inspection when all vermin and evidence of vermin are eliminated from the facility. The facility must remain closed for at least 24 hours prior to the follow up inspection.
