Inspector Comments: Observed a large pitcher in the hand washing sink in the back room.

Ensure hand washing sink is used for hand washing only and is not blocked or obstructed in any way to promote proper hand washing.

Corrected on site. Employee was notified and removed pitcher immediately.

Violation Description: Handwashing soap and towels or drying device shall be provided in dispensers; dispensers shall be maintained in good repair. (113953.2) Adequate facilities shall be provided for hand washing. (113953, 113953.1, 114067(f)). Handwashing sink is not separated from a warewashing sink by a 6 inch high metal splashguard or 24 inch separation. (113953) Handwashing sinks shall not be obstructed, inaccessible, used improperly or kept unclean. (113953.1)
