No corrections have been made according to the Plan Check Preliminary Inspection or the reinspection conducted on 4/9/2015. Operator continues to use. Observed prepared sandwiches and burritos in convenience store.

Operator has received approvals from San Bernardino County Fire Department to use ventilation system, however approvals have not been given from the Environmental Health Plan Check Department.

Immediately cease and desist all food preparation. No food preparation is to be conducted at facility until final approval from the Environmental Health Plan Check Department has been given, and a valid health permit has been obtained.

Follow up reinspections will be conducted to observe compliance and will be charged at the current hourly rate of \$245.00 per hour.

Complete construction per the approved plan. If unable to accommodate shelving or any other requirement, submit a Change to Approved Plan to Environmental Health for review.
