Inspector Comments: A complaint inspection was conducted on this date 5/7/2021 based on a complaint received by Environmental Health Services. Complaint had stated that they had found a cockroach in their burrito.

Person in charges of complaints for the facility was asked if they had received any complaints or were aware of the complaint and stated they were not. Facility was asked if they have had pest control issues in the past and stated they did not. Person in charge provided pest control invoice from Lloyd Pest Control service dated 5/7/2021. Inspection of facility noted live active infestation of german cockroaches. Eggs, Nymphs, and Adult German Cockroaches were observed throughout the entire facility including customer dining area, register area, kitchen area including preparation line and cooks line, ware washing area, walk-in refrigerator hallway, and back storage rooms. Few roaches were found to be slow and dying from recent pest control service but majority were observed to be fully active.

Lloyd Pest Control representative was met on site and was spoken to about the active infestation. Lloyd Pest Control Service representative was made aware of the areas of concern and stated they will contact their company to get a scheduled technician to come service the site.

Owner was spoken to at the end of the inspection and was given instructions for the facility:

- Facility is to remain closed for a minimum of 24 hours
- Facility will need to eliminate all cockroaches, alive and dead, from the facility and ensure there is no continued infestation
- Facility will need to properly clean and sanitize all equipment and utensils in the facility
- All holes and gaps in facility walls and ceilings will need to be sealed
- Additional pest control service will need to be conducted and verified via invoice
- All trash and debris in the facility will need to be removed and areas cleaned
- All food will need to be inspected for adulteration and to ensure quality

If facility is ready to reopen on the weekend facility is instructed to contact the After Hours Emergency Communication Center at 1-800-472-2376.

San Bernardino County Environmental Health Services operates from 8AM-5PM Monday to Friday.
