Handwashing sink is not separated from a warewashing sink by a 6 inch high metal splashguard or 24 inch separation. (113953) Handwashing sinks shall not be obstructed, inaccessible, used improperly or kept unclean. (113953.1)

Hot water temperature observed declining, reaching a maximum temperature of 111F. Ensure to maintain a minimum temperature of 120F at prep sink. Reinspection required in 48 hours to verify hot water temperature is maintained at 120F at all times throughout facility.

**Violation Description:** An accurate easily readable metal probe thermometer suitable for measuring temperature of food shall be available to the food handler. A thermometer +/- 2 F shall be provided for each hot and cold holding unit of potentially hazardous foods and high temperature warewashing machines. (114157, 114159)
