POINTS 4	Compliance date not specified	Inspector Comments: Observed an employee touch the inner rim of a trash can and then resume slicing at the meat slicer without first washing their hands. Ensure all employees wash their hands after contamination occurs and before handling food or equipment. Corrective action : Employee washed their hands.

Violation Description: Employees are required to wash their hands: before beginning work; before handling food / equipment / utensils; as often as necessary, during food preparation, to remove soil and contamination; when switching from working with raw to ready to eat foods, after touching body parts; after using toilet room; or any time when contamination may occur. Gloves shall be worn if an employee has cuts, wounds, fake nails, nail polish, and/or rashes. Gloves are to be used for no more than one task. Employees are not to wrap or package leftover food using bare hands or unclean utensils. Hand sanitizers may be used after proper hand washing. Employees handling food must have fingernails that are trimmed, cleanable, and smooth. (113952, 113953.3, 113953.4, 113961, 113968, 113973 (b-f))

POINTS 2	Compliance date not specified	Inspector Comments: Missing soap at the handwash sink in the front bar area. Missing mounted paper towel dispensers in both bar areas. Mount paper towel dispensers and keep both paper towel dispensers and soap dispensers stocked at all times.

	Violation Reference -	Observed faucet handles near the dishwashing machine sticky to the touch. Clean and maintain the faucet handles.

Violation Description: Handwashing soap and towels or drying device shall be provided in dispensers; dispensers shall be maintained in good repair. (113953.2) Adequate facilities shall be provided for hand washing. (113953, 113953.1, 114067(f)). Handwashing sink is not separated from a warewashing sink by a 6 inch high metal splashguard or 24 inch separation. (113953) Handwashing sinks shall not be obstructed, inaccessible, used improperly or kept unclean. (113953.1)

POINTS 1	Compliance date not specified	Inspector Comments: Observed several uncovered containers of ready to eat food in reach in coolers throughout the kitchen. Cover food to prevent possible contamination.

	Violation Reference - HSC - 113984 (a, b, c, d, f)	Observed scoops of handles in bulk food bins in contact with the food. Store all scoops with their handles outside of the food.

Violation Description: All food shall be separated and protected from contamination. (113984 (a, b, c, d, f), 113986, 114060, 114067(a, d, e, j), 114069(a, b), 114077, 114089.1 (c), 114143 (c)) All food shall be stored, prepared, displayed or held so that it is protected from contamination.

POINTS 1	Compliance date not specified	Inspector Comments: Observed an empty canned beverage and the bottom of a plunger stored on the shelf above the 3 compartment sink. Clean and sanitize the area and maintain it clean.

	Violation Reference - HSC - 114067(f,g), 114099	Observed a hole in the tubing attached to the sanitizer line at the 3 compartment sink. Replace the tube.

Violation Description: Food facilities that prepare food shall be equipped with warewashing facilities. Testing equipment and materials shall be provided to measure the applicable sanitization method. (114067(f,g), 114099, 114099.3, 114099.5, 114101(a), 114101.1, 114101.2, 114103, 114107, 114125) A thermometer must be readily available to monitor the temperature of the water at the warewashing sink. A warewashing sink used to wash wiping cloths, wash produce, or thaw food must be cleaned and sanitized before and after each use.
