Inspector Comments: Observed the back reach in cold holding unit to be measuring at 50F and food items inside measuring between 49F-53F. Person in charge stated that food items inside had been in use and placed inside approximately an hour prior to time of inspection. Observed the following food items measuring between 49-53F:

- One (1) container of ham
- One (1) container of shredded chicken
- One (1) container of sausage patties
- One (1) bag of bacon
- Two(2) egg cartons

Ensure that all potentially hazardous foods are held at or below 41F for cold holding or 135F and above for hot holding.

Note: Person in charge was instructed to place all food items into an ice bath for rapid cooling.

Violation Description: Potentially hazardous foods shall be held at or below 41F or at or above 135F. (113996, 113998, 114037, 114343(a))

Inspector Comments: Observed the handwashing sink located next to the three compartment sink to have no paper towels.

Ensure that all handwashing sinks are clean, unobstructed, accessible, and provided with hand soap and paper towels in a dispenser at all times.

Violation Description: Handwashing soap and towels or drying device shall be provided in dispensers; dispensers shall be maintained in good repair. (113953.2) Adequate facilities shall be provided for hand washing. (113953, 113953.1, 114067(f)). Handwashing sink is not separated from a warewashing sink by a 6 inch high metal splashguard or 24 inch separation. (113953) Handwashing sinks shall not be obstructed, inaccessible, used improperly or kept unclean. (113953.1)

Inspector Comments: Observed several dead cockroaches under the 3-compartment sink, hand sink, and behind the upright refrigerator. Person in charge stated pest control services come monthly or upon request.

Clean and sanitize area and maintain facility free of vermin.

Violation Description: Food facility shall be kept free of vermin: rodents (rats, mice), cockroaches, flies. (114259.1, 114259.4, 114259.5) Live animals are not allowed in a food facility unless, food employees with service animals may handle or care for their service animal if they wash their hands as required or persons who are licensed pursuant to Chapter 11.5 of Division 3 of the Business and Professions Code. (114259.4, 114259.5)

Discontinue this practice. Ensure all food is stored, prepared, displayed or held so that it is protected from contamination.

Violation Description: All food shall be separated and protected from contamination. (113984 (a, b, c, d, f), 113986, 114060, 114067(a, d, e, j), 114069(a, b), 114077, 114089.1 (c), 114143 (c)) All food shall be stored, prepared, displayed or held so that it is protected from contamination.

Violation Description: Food shall be stored in approved containers and labeled as to contents. Food shall be stored at least 6" above the floor on approved shelving in an approved location to prevent possible contamination. (114047, 114049, 114051, 114053, 114055, 114067(h), 14069 (b))

Repair/replace and ensure all equipment and utensils are maintained fully operative ans in good repair at all times.

2. Observed a Kenmore household freezer chest across from the metal storage racks.

Ensure all equipment is certified by an ANSI/NSF accredited certification program, or if no standard exists, is approved by the local enforcement agency.

3. Observed the digital thermometer of the upright refrigerator (holding potentially hazardous food) to read 50F. Ambient temperature was also measured at 50F.

Repair/replace and ensure all equipment and utensils are maintained fully operative ans in good repair at all times.

Note: The person in charge adjusted the ambient temperature to measure 40F. Corrected onsite.

Violation Description: All utensils and equipment shall be fully operative and in good repair. (114175). All utensils and equipment shall be approved, installed properly, and meet applicable standards. (114130, 114130.1, 114130.2, 114130.3, 114130.4, 114130.5, 114132, 114133, 114137, 114139, 114153, 114155, 114163, 114165, 114167, 114169, 114177, 114180, 114182)

Inspector Comments: Observed several boxes of aluminum foil stored inside of the second employee/customer restroom that the person in charge stated is not being used, and in the hall way outside of the employee/customer restrooms.

Discontinue this practice. Remove paper goods, food equipment and ensure all utensils and equipment is stored as to be protected from contamination.

Violation Description: All clean and soiled linen shall be properly stored; non-food items shall be stored and displayed separate from food and food-contact surfaces. (114185.3 - 114185.4) Utensils and equipment shall be handled and stored so as to be protected from contamination. (114074 - 114075, 114081, 114119, 114121, 114161, 114178, 114179, 114083, 114185, 114185.2, 114185.5) Pressurized cylinders must be securely fastened to a rigid structure. (114172)

40. WIPING CLOTHS: PROPERLY USED AND STORED

Inspector Comments: Observed several wet wiping clothes stored throughout the front counter.

Discontinue this practice. Ensure that wet wiping clothes are returned to sanitizer bucket with a concentration of 100ppm chlorine or at least 200ppm quaternary ammonia when not in use.

Note: Sanitizer bucket was measured at 100ppm during the time of inspection.

Violation Description: Wiping cloths used to wipe service counters, scales or other surfaces that may come into contact with food shall be used only once unless kept in clean water with sanitizer. (114135, 114185.1, 114185.3 (d-e)) Sponges shall not be used in contact with cleaned and sanitized or in-use food contact surfaces. (114135)

Inspector Comments: Observed an insufficient air gap from the water waste pipe at the floor drain under the rear 3-compartment sink.

Ensure to maintain an air gap of at least one (1) inch between draining pipes and floor sink.

Violation Description: The potable water supply shall be protected with a backflow or back siphonage protection device, as required by applicable plumbing codes. (114192) All plumbing and plumbing fixtures shall be installed in compliance with local plumbing ordinances, shall be maintained so as to prevent any contamination, and shall be kept clean, fully operative, and in good repair. Any hose used for conveying potable water shall be of approved materials, labeled, properly stored, and used for no other purpose. (114171, 114189.1, 114190, 114193, 114193.1, 114199, 114201, 114269)

Observed approximately an inch gap around the back delivery door. Provide a weather strip. Maintain the facility in a manner that prevents the entrance or harborage of vermin. 3. Observed several open drinks stored on the preparation table while person in charge was food handling. Discontinue this practice. Ensure employees do not eat or drink in non-designated areas where contamination may result.

Violation Description: The premises of each food facility shall be kept clean and free of litter and rubbish; all clean and soiled linen shall be properly stored; non-food items shall be stored and displayed separate from food and food-contact surfaces; the facility shall be kept vermin proof. (114067 (j), 114123, 114143 (a) & (b), 114256, 114256.1, 114256.2, 114256.4, 114257, 114257.1, 114259, 114259.2, 114259.3, 114279, 114281, 114282) Food preparation sinks, handwashing sinks and warewashing equipment shall not be used for the cleaning of maintenance tools, the holding of maintenance materials, or the disposal of liquid wastes. (114123) Open-air barbecue and/or outdoor wood burning oven must operate on the same premises, in conjunction with a permanent food facility and not in an area that may pose as a fire hazard. Violation Description: The walls / ceilings shall have durable, smooth, nonabsorbent, and washable surfaces. All floor surfaces, other than the customer service areas, shall be approved, smooth, durable and made of nonabsorbent material that is easily cleanable. Approved base coving shall be provided in all areas, except customer service areas and where food is stored in original unopened containers. Food facilities shall be fully enclosed. All food facilities shall be kept clean and in good repair. (114143 (d), 114257, 114266, 114268, 114268.1, 114271, 114272) Cleaning must be an approved dustless method. (114268.1) Mats and duckboards, if used, must be removable and easily cleanable. (114272) Open-air barbecues or wood-burning ovens floor surfaces must extend a minimum of five feet and be impervious or easily cleanable. (114143(d))

- A score letter of "B" on two of the last three graded inspections,
- Repeated "four (4) point violation Risk Factor" (critical violation codes 1-23) on the last two inspections, or
- Four (4) or more critical violations (codes 1-23) noted during an inspection, or
