**Inspector Comments:** Observed no hand washing set up at the San Bernardino Air show on November 2, 2019.

Operator was advised without a means to adequately wash hands, temporary food facility is not advised to operate.

Ensure handwashing facilities must be available, accessible, and equipped with pump soap, paper towels, a catch basin and hands free running water for proper hand washing. Hand washing facilities must be set up prior to starting any food preparation or handling any open foods.

**Violation Description:** Handwashing facilities must be available, accessible, and equipped with pump soap, paper towels, a catch basin and hands free running water for proper hand washing. Hand washing facilities must be set up prior to starting any food preparation or handling any open foods. Warewash sink shall not be used for handwashing.
