Ensure all food in the facility is covered, protected and sealed to help eliminate the entry of vermin.

Violation Description: All food shall be manufactured, produces, prepared, compounded, packed, transported, kept for sale, and served so as to be pure and free from adulteration and spoilage. Any food is adulterated if it bears or contains any poisonous or deleterious substance that may render it impure or injurious to health. Inspector Comments: Observed live German cockroach crawling in box of lettuce, on 3-comp sink, on counter top where wrapping paper for consumers is located, on walls behind refrigerator, on floors next to soda display refrigerator under prep sink and under 3-comp sink. Approx 10 live German cockroaches observed throughout the facility. Observed 20-40 dead cockroaches throughout the facility. Immediately eliminate cockroach infestation. Clean up dead cockroaches. Take the necessary steps to eliminate cockroach infestation.

Observed no pest control records.

Ensure to obtain a pest control service immediately.

Signs of food contamination observed. Observed 3 live cockroaches on box of lettuce.

Violation Description: Food facility shall be kept free of vermin: rodents (rats, mice), cockroaches, flies. (114259.1, 114259.4, 114259.5) Live animals are not allowed in a food facility unless, food employees with service animals may handle or care for their service animal if they wash their hands as required or persons who are licensed pursuant to Chapter 11.5 of Division 3 of the Business and Professions Code. (114259.4, 114259.5)

Discontinue the process of using home base products in the facility.

Ensure to obtain a license pest control manager for eradication of vermin.

Violation Description: All poisonous substances, detergents, bleaches, and cleaning compounds shall be stored separate from food, utensils, packing material and food-contact surfaces. (114254, 114254.1, 114254.2) An insecticide, rodenticide, or other pesticide must be used in accordance with the manufacturer's instructions.

A thermometer +/- 2 F shall be provided for each hot and cold holding unit of potentially hazardous foods and high temperature warewashing machines. (114157, 114159)

Observed holes, cracks and missing wall plates on the walls through out the facility. Ensure to properly seal all cracks, crevices and mount wall plates.

Observed damaged FRP board and cove base. Ensure to repair/replace damaged FRP boards and cove base to help eliminate the potential for vermin harboring

Violation Description: The walls / ceilings shall have durable, smooth, nonabsorbent, and washable surfaces. All floor surfaces, other than the customer service areas, shall be approved, smooth, durable and made of nonabsorbent material that is easily cleanable. Approved base coving shall be provided in all areas, except customer service areas and where food is stored in original unopened containers. Food facilities shall be fully enclosed. All food facilities shall be kept clean and in good repair. (114143 (d), 114257, 114266, 114268, 114268.1, 114271, 114272) Cleaning must be an approved dustless method. (114268.1) Mats and duckboards, if used, must be removable and easily cleanable. (114272) Open-air barbecues or wood-burning ovens floor surfaces must extend a minimum of five feet and be impervious or easily cleanable. (114143(d))
