

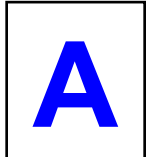

POINTS 1	Compliance date not specified Complied on 11/5/2020 Violation Reference - HSC - 113984 (a, b, c, d, f)	Inspector Comments: Observed a hot holding unit with tamales and a hot holding unit with champurrado to be stored on a table (accessible to customers) that is located on the sales floor, in front of the bakery department. Observed a customer grabbing the units and removing the covers/lids from the units. The manager stated that employees serve the customers. Observed no employees at the table at the time of inspection.

All food shall be stored, prepared, displayed, or held so that it is protected from contamination.

Note: The employee relocated the units to inside the bakery department. Corrected onsite.

Violation Description: All food shall be separated and protected from contamination. (113984 (a, b, c, d, f), 113986, 114060, 114067(a, d, e, j), 114069(a, b), 114077, 114089.1 (c), 114143 (c)) All food shall be stored, prepared, displayed or held so that it is protected from contamination.

Utensils and equipment shall be handled and stored so as to protect food from possible contamination.

Note: The manager discarded the bread/cookies. See VC&D for details.

Violation Description: All clean and soiled linen shall be properly stored; non-food items shall be stored and displayed separate from food and food-contact surfaces. (114185.3 - 114185.4) Utensils and equipment shall be handled and stored so as to be protected from contamination. (114074 - 114075, 114081, 114119, 114121, 114161, 114178, 114179, 114083, 114185, 114185.2, 114185.5) Pressurized cylinders must be securely fastened to a rigid structure. (114172)

Violation Description: Toilet facilities shall be maintained clean, sanitary and in good repair for use by employees and patrons. Toilet rooms shall be separated by a well-fitting, self-closing door. Toilet tissue shall be provided in a permanently installed dispenser at each toilet. Location of toilet facilities used by patrons shall not be located to pass through food preparation, food storage, or utensil washing areas. (114250, 114250.1, 114276)

Violation Description: This facility is currently in violation with the food handler certification requirement for San Bernardino County, which states all food handlers must obtain a valid food handler certificate within fourteen (14) days of employment (33.0410, 33.044). Failure to provide proof of food handler certification within fourteen (14) days will result in unannounced billable (at our current hourly rate) re-inspections to verify compliance.
