Facility must be free of vermin and vermin evidence.  Last inspection report was on 12/2/20 and unclear if activity was noted.

**Violation Description:** Food facility shall be kept free of vermin: rodents (rats, mice), cockroaches, flies. (114259.1, 114259.4, 114259.5) Live animals are not allowed in a food facility unless, food employees with service animals may handle or care for their service animal if they wash their hands as required or persons who are licensed pursuant to Chapter 11.5 of Division 3 of the Business and Professions Code. (114259.4, 114259.5)

Process all multi-use utensils using the following three steps: 1). Compartment / Step #1-Wash / Soap-Soap and hot water (Water at least 100 F). 2). Compartment / Step #2-Rinse-Hot water rinse 3). Compartment / Step #3-Sanitizer-Contact with chlorine at a minimum of 100 ppm-200 ppm Chlorine for a minimum of 30 seconds .  Note-This violation was corrected on site and kitchen staff were trained and educated as to the proper procedure

(114074 - 114075, 114081, 114119, 114121, 114161, 114178, 114179, 114083, 114185, 114185.2, 114185.5) Pressurized cylinders must be securely fastened to a rigid structure. (114172)

(114192) All plumbing and plumbing fixtures shall be installed in compliance with local plumbing ordinances, shall be maintained so as to prevent any contamination, and shall be kept clean, fully operative, and in good repair. Any hose used for conveying potable water shall be of approved materials, labeled, properly stored, and used for no other purpose. (114171, 114189.1, 114190, 114193, 114193.1, 114199, 114201, 114269)
