NATURE OF COMPLAINT:

The complainant alleged that the facility has removed and hidden their "C" grade card from public view.

FINDING(S):

The food facility manager was interviewed over the phone and the following information was provided:

- Store manager was educated on San Bernardino County Code requirements regarding proper display of the facility grade card. Facility grade card shall be posted in an area that is visible to patrons. Once posted by the inspector DO NOT REMOVE, RELOCATE OR MOVE GRADE CARD.

-Store manager was told that inspector will confirm compliance later in the day to verify that the grade card is posted.

OBSERVATION(S):

- Inspector observed grade card posted, next to the main entry door, on this day.

No violations were noted.

This concludes the complaint investigation.
