**Inspector Comments:** A complaint inspection was conducted in response to a complaint received by Environmental Health Services.

NATURE OF COMPLAINT:

The complainant alleged that there were cockroaches in the cafe.

The manager was not aware of the complaint.

FINDINGS:

The manager stated the following:

- -The facility was experiencing an active infestation
- -The issue had been occurring for between one (1) to two (2) months prior to inspection
- -A pest control company serviced the facility weekly, for a total of four (4) to five (5) times

Observed live German cockroaches in the following areas:

- -Six (6) live cockroaches on a trap on the floor underneath the counter containing espresso machines
- -Two (2) live cockroaches underneath the front service counter
- -Two (2) live cockroaches on a trap on the floor underneath the baked goods display unit
- -Two (2) live cockroaches underneath the three (3) compartment sink

Observed dead German cockroaches in the following areas:

- -Several dead cockroaches on traps underneath the front service counter
- -Three (3) dead cockroaches in the cupboards storing dry goods behind the front service counter
- -Two (2) dead cockroaches in the back storage area
- -Three (3) dead cockroaches underneath the three (3) compartment sink

The permit is suspended on this date due to an active cockroach infestation. A reinspection is required prior to reopening the facility.

- -Remove/eliminate all evidence of the cockroaches using an approved method of pest control as soon as possible.
- -Seal all gaps/crevices in the facility
- -Clean and sanitize the affected areas.

All evidence of cockroach activity must be eliminated from the facility prior to reopening. The facility must remain closed for at least 24 hours prior to reopening.

Violation Description: If an imminent health hazard is found, an enforcement officer may temporarily suspend the permit and order the food facility immediately closed. (114409, 114405)

**Inspector Comments:** 1. Observed live German cockroaches in the following areas:

- -Six (6) live cockroaches on a trap on the floor underneath the counter containing espresso machines
- -Two (2) live cockroaches underneath the front service counter
- -Two (2) live cockroaches on a trap on the floor underneath the baked goods display unit
- -Two (2) live cockroaches underneath the three (3) compartment sink
- 2. Observed dead German cockroaches in the following areas:
- -Several dead cockroaches on traps underneath the front service counter
- -Three (3) dead cockroaches in the cupboards storing dry goods behind the front service counter
- -Two (2) dead cockroaches in the back storage area
- -Three (3) dead cockroaches underneath the three (3) compartment sink

Ensure the facility is free of vermin at all times.

A reinspection is required prior to reopening to determine compliance.

**Violation Description:** Food facility shall be kept free of vermin: rodents (rats, mice), cockroaches, flies. (114259.1, 114259.4, 114259.5) Live animals are not allowed in a food facility unless, food employees with service animals may handle or care for their service animal if they wash their hands as required or persons who are licensed pursuant to Chapter 11.5 of Division 3 of the Business and Professions Code. (114259.4, 114259.5)

### 16C045 Floors, walls and ceilings: built, maintained, and clean

**Inspector Comments:** 1. Observed a large hole in the floor underneath the counter holding the espresso machines

Violation Reference - HSC - 114143 (d), 114266

Seal the hole or repair/replace the floor tile in this area and maintain in good repair.

2. Observed heavy debris and residue accumulation on the floor underneath the counter holding the espresso machine.

Clean the floor and maintain the floors clean

Violation Description: The walls / ceilings shall have durable, smooth, nonabsorbent, and washable surfaces. All floor surfaces, other than the customer service areas, shall be approved, smooth, durable and made of nonabsorbent material that is easily cleanable. Approved base coving shall be provided in all areas, except customer service areas and where food is stored in original unopened containers. Food facilities shall be fully enclosed. All food facilities shall be kept clean and in good repair. (114143 (d), 114257, 114266, 114268, 114268.1, 114271, 114272) Cleaning must be an approved dustless method. (114268.1) Mats and duckboards, if used, must be removable and easily cleanable. (114272) Open-air barbecues or wood-burning ovens floor surfaces must extend a minimum of five feet and be impervious or easily cleanable. (114143(d))

### **Overall Inspection Comments**

The permit was suspended on this date due to an active cockroach infestation.

The facility must remain closed for at least 24 hour prior to reinspection. Call Environmental Health Services at (800) 442-2283 for a reinspection prior to reopening.
