**Inspector Comments:** Environmental Health received a complaint stating, "as I was eating breakfast yesterday morning a cockroach was observed walking on the wall next to me".

Reference - HSC

Discussed nature of complaint with person in charge who was not aware of complaint. No other complaints of this nature have been made.

Upon inspection, two (2) dead cockroaches were observed on floor beneath 2 booths. One (1) small, dead cockroach was observed on floor behind front counter adjacent to a sanitizer bucket. No live cockroaches observed throughout dining area or kitchen.

Clean dead roaches to aid in monitoring for activity.

Person in charge stated pest control services facility once per month. During inspection, invoices for pest control were not available.

Complaint closed.
