



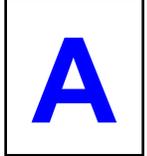

Inspector Comments: Observed sliced tomatoes holding at 56 F in the cold unit next to the cook's line. Employee stated the tomatoes had been there for approximately three hours.

Ensure all potentially hazardous foods for cold holding are maintained at an internal temperature of 41 F at all times.

Corrected on site. Employee voluntarily discarded the sliced tomatoes. See VC&D.

Violation Description: Potentially hazardous foods shall be held at or below 41F or at or above 135F. (113996, 113998, 114037, 114343(a))

40. WIPING CLOTHS: PROPERLY USED AND STORED

Inspector Comments: Observed wet wiping cloths stored in several places on the counters at the burrito prep area and near the cook's line.

Ensure all wet wiping cloths are stored in sanitizer solution at the correct concentration (100 PPM for chlorine and 200 PPM for quaternary ammonium) when not in use.

Violation Description: Wiping cloths used to wipe service counters, scales or other surfaces that may come into contact with food shall be used only once unless kept in clean water with sanitizer. (114135, 114185.1, 114185.3 (d-e)) Sponges shall not be used in contact with cleaned and sanitized or in-use food contact surfaces. (114135)

41. PLUMBING; PROPER BACKFLOW DEVICES

Inspector Comments: Observed leaking pipe at the 3-compartment sink and leaking faucet in the men's restroom.

Repair/replace leaking plumbing and faucet and maintain all plumbing in good condition.

Observed drain pipe below the ice machine resting in the floor sink.

Ensure an air gap of 1-inch or twice the diameter of the pipe (whichever is greater) is present between the top of the floor sink and the bottom of the drain pipe to prevent potential contamination.

Violation Description: The potable water supply shall be protected with a backflow or back siphonage protection device, as required by applicable plumbing codes. (114192) All plumbing and plumbing fixtures shall be installed in compliance with local plumbing ordinances, shall be maintained so as to prevent any contamination, and shall be kept clean, fully operative, and in good repair. Any hose used for conveying potable water shall be of approved materials, labeled, properly stored, and used for no other purpose. (114171, 114189.1, 114190, 114193, 114193.1, 114199, 114201, 114269)

Inspector Comments: Observed damaged tile coving along the edge of the wall near the ice machine.

Repair/replace damaged coving tiles and maintain in good condition.

Violation Description: The walls / ceilings shall have durable, smooth, nonabsorbent, and washable surfaces. All floor surfaces, other than the customer service areas, shall be approved, smooth, durable and made of nonabsorbent material that is easily cleanable. Approved base coving shall be provided in all areas, except customer service areas and where food is stored in original unopened containers. Food facilities shall be fully enclosed. All food facilities shall be kept clean and in good repair. (114143 (d), 114257, 114266, 114268, 114268.1, 114271, 114272) Cleaning must be an approved dustless method. (114268.1) Mats and duckboards, if used, must be removable and easily cleanable. (114272) Open-air barbecues or wood-burning ovens floor surfaces must extend a minimum of five feet and be impervious or easily cleanable. (114143(d))
