POINTS 4	Compliance date not specified Complied on 4/3/2015 Violation Reference - HSC - 113984(e), 114097, 114099	Inspector Comments: Observed one of the bar mechanical warewashers is not sanitizing, there is no detectable chlorine residual; Mechanical sanitation shall be accomplished in the final sanitizing rinse by contact with a solution of 50 [maximum 200] ppm available chlorine for at least 30 seconds. Observed by questioning a staff member is not washing the utensils before sanitizing; The facility must wash-rinse-sanitize-air dry as per CalCode. Do not rinse off the sanitizer.

Observed the cove base in the walk-in beer cooler is held down with globs of caulking; All equipment must be smooth and easily cleanable.

Violation Description: The walls / ceilings shall have durable, smooth, nonabsorbent, and washable surfaces. All floor surfaces, other than the customer service areas, shall be approved, smooth, durable and made of nonabsorbent material that is easily cleanable. Approved base coving shall be provided in all areas, except customer service areas and where food is stored in original unopened containers. Food facilities shall be fully enclosed. All food facilities shall be kept clean and in good repair. (114143 (d), 114257, 114266, 114268, 114268.1, 114271, 114272) Cleaning must be an approved dustless method. (114268.1) Mats and duckboards, if used, must be removable and easily cleanable. (114272) Open-air barbecues or wood-burning ovens floor surfaces must extend a minimum of five feet and be impervious or easily cleanable. (114143(d))
