**Inspector Comments:** During routine inspection on 2-10-15, facility was missing 10 food worker cards.

During billable reinspection, facility had not obtained all of the food worker cards. Inspector verified 3 of the 10 missing cards. Manager informed inspector that 1 of the 10 people had quit since the inspection; manager was instructed to include termination paperwork for that individual.

Facility has been granted an additional 7 days to comply with food worker card requirement. Fax in completed food worker card form for compliance.

If compliance is not met within the 7 day time frame, inspector will return for an additional billable inspection for food worker card compliance.

**Violation Description:** During your last routine inspection, it was noted that your facility was in violation of the food worker certification requirement for San Bernardino County. Since the inspection, food worker certification compliance has not been verified by Environmental Health staff. A billable reinspection has been conducted on this date to verify compliance.
