Inspector Comments: Wash hands when handling soiled dishes then clean dishes.

Wash hands with warm water (100F), soap, and dry with paper towels.

Observed employee handle soiled dishes then clean dishes. Employee washed hands with cold water at 70F.

Corrected on site. Employee washed hands with soap and warm water and dried with paper towels.

Violation Description: Employees are required to wash their hands: before beginning work; before handling food / equipment / utensils; as often as necessary, during food preparation, to remove soil and contamination; when switching from working with raw to ready to eat foods, after touching body parts; after using toilet room; or any time when contamination may occur. Gloves shall be worn if an employee has cuts, wounds, fake nails, nail polish, and/or rashes. Gloves are to be used for no more than one task. Employees are not to wrap or package leftover food using bare hands or unclean utensils. Hand sanitizers may be used after proper hand washing. Employees handling food must have fingernails that are trimmed, cleanable, and smooth. (113952, 113953.3, 113953.4, 113961, 113968, 113973 (b-f))
