

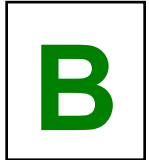

5. HANDS CLEAN AND PROPERLY WASHED; GLOVES USED PROPERLY **MAJOR**

Inspector Comments: Observed an employee wash their single use gloves and then begin to prepare food.

Discontinue this practice. Gloves must be discarded when soiled and hands must be washed before beginning a new food contact task.

Corrected on Site: Employee was instructed to remove their gloves and wash their hands before continuing with food preparation.

Violation Description: Employees are required to wash their hands: before beginning work; before handling food / equipment / utensils; as often as necessary, during food preparation, to remove soil and contamination; when switching from working with raw to ready to eat foods, after touching body parts; after using toilet room; or any time when contamination may occur. Gloves shall be worn if an employee has cuts, wounds, fake nails, nail polish, and/or rashes. Gloves are to be used for no more than one task. Employees are not to wrap or package leftover food using bare hands or unclean utensils. Hand sanitizers may be used after proper hand washing. Employees handling food must have fingernails that are trimmed, cleanable, and smooth. (113952, 113953.3, 113953.4, 113961, 113968, 113973 (b-f))

14. FOOD CONTACT SURFACES: CLEAN AND SANITIZED **MAJOR**

Inspector Comments: Measured the chlorine sanitizer at the mechanical warewashing machine at 0 ppm chlorine.

Chlorine sanitizer must measure a minimum of 50 ppm from the mechanical warewashing machine.

Note: Employees were instructed not to only use the three (3) compartment sink until the mechanical warewashing machine has been fixed.

A reinspection will be done on or after three (3) days to ensure the mechanical warewashing machine had been fixed. Failure to comply may result in billed reinspection.

Violation Description: All food contact surfaces of utensils and equipment shall be clean and sanitized. (113984(e), 114097, 114099.1, 114099.4, 114099.6, 114101 (b-d), 114105, 114109, 114111, 114113, 114115 (a, b, d), 114117, 114125(b), 114135, 114141)

7. PROPER HOT AND COLD HOLDING TEMPERATURES

Inspector Comments: Measured a yogurt based sauce at 52 F in the cold holding unit next to the hot holding line. Per employee, the yogurt based sauce had been placed there two (2) hours prior to inspection.

Note: Ambient temperature of the cold holding unit measured 49 F.

Discontinue use of this cold holding unit for potentially hazardous foods until fixed. Maintain all potentially hazardous food in cold holding at or below 41 F.

Corrected on Site: Yogurt sauce was removed from cold holding unit and placed in the back reach-in cooler to rapidly cool to 41 F.

A reinspection will be done on or after three (3) days to ensure the mechanical warewashing machine had been fixed. Failure to comply may result in billed reinspection.

Violation Description: Potentially hazardous foods shall be held at or below 41F or at or above 135F. (113996, 113998, 114037, 114343(a))

POINTS 2	Compliance date not specified Not In Compliance Violation Reference - HSC - 114197	<p>Inspector Comments: Observed the floor sink beneath the three (3) compartment sink clogged.</p> <p>Note: No sewage back up was observed coming from the floor sink.</p> <p>Ensure liquid waste drains to an approved fully functioning sewage disposal system.</p> <p>Corrected on Site: An employee unclogged the floor sink and it was observed fully functioning.</p>

Violation Description: All liquid waste must drain to an approved fully functioning sewage disposal system. (114197) Toilet facilities must be operable.

23. NO RODENTS, INSECTS, BIRDS, OR ANIMALS

POINTS 2	Compliance date not specified Not In Compliance Violation Reference - HSC - 114259.1, 114259.4, 11425	<p>Inspector Comments: Observed four (4) dead nymph cockroaches along the back exit door wall. After a thorough search of the facility, no signs of an active infestation were observed.</p> <p>Note: No food or food contact surfaces were observed to be contaminated. Per manager, they are serviced on a monthly basis for pest control treatments.</p> <p>Clean all affected areas and eliminate the vermin from the facility.</p> <p>A reinspection will be done on or after three (3) days to ensure the mechanical warewashing machine had been fixed. Failure to comply may result in billed reinspection.</p>

Violation Description: Food facility shall be kept free of vermin: rodents (rats, mice), cockroaches, flies. (114259.1, 114259.4, 114259.5) Live animals are not allowed in a food facility unless, food employees with service animals may handle or care for their service animal if they wash their hands as required or persons who are licensed pursuant to Chapter 11.5 of Division 3 of the Business and Professions Code. (114259.4, 114259.5)

IMPORTANT: Risk Based Inspection Frequency

Food facilities that pose a higher risk level for causing foodborne illness will be subject to an additional inspection, to be billed at the hourly rate as provided in the San Bernardino County Code [Schedule of Fees](#). Facilities that received one or more of the following will be elevated to a high risk tier:

- A score letter of "C" or lower on one of the last two graded inspections,
- A score letter of "B" on two of the last three graded inspections,
- Repeated "four (4) point violation Risk Factor" (critical violation codes 1-23) on the last two inspections, or
- Four (4) or more critical violations (codes 1-23) noted during an inspection, or
