The owner produced a receipt for pest control services (XCEL Pest Control, Beaumont, CA) documenting the application of roach control gel bait. The owner stated that she agreed to monthly pest control services for the year.

No additional follow up inspections are needed. Facility reopened and the permit reinstated.
