On this date, all major violations previously noted on 10/3/2018 have been corrected and no evidence of live vermin activity observed, including cockroaches, at the time of re-inspection.

The permit of this facility was reinstated on this date. Notice of Closure sign was removed and Facility Under Review sign was posted at the front entrance. This facility may now open and operate to the public.

A request of a re-score has been received by this office. A graded re-score inspection will be conducted within ten (10) days of today's date.

**Description:** The health permit to operate is hereby reinstated and facility may open.

#### Inspector Comments:

On this date, this facility re-inspection was requested by the operator. This facility was closed at the time of re-inspection. During a graded routine inspection on 10/3/2018, this facility received a score of a 66 and the health permit was suspended due to a score under 70 and evidence of a live cockroach infestation. .

At the time of re-inspection, all major violations previously noted on 10/3/2018 were observed to have been corrected. After a complete thorough inspection of the entire kitchen facility, no evidence of vermin, including cockroaches, was observed on this date. The owner/operator provided professional fumigation receipts dated 10/4/2018 and 10/8/2018 that showed this facility was serviced by a professional exterminator.

**Description:** Reinspection conducted at this time to determine compliance from prior inspection.
