<b>POINTS</b> <b>4</b>	Compliance date not specified Complied on 11/17/2015 Violation Reference - HSC - 113967, 113976,	<b>Inspector Comments:</b> Observed water from the ceiling leaking into a container of salt and a container of ice.  Discontinue allowing for the adulteration of food.  Corrective Action: The ice and salt were discarded and a bucket was placed beneath the leak. Repairman was on site addressing the issue prior to start of the inspection. Will return to verify leak has been eliminated. Clean and sanitize all affected areas and discard any other food that may have become contaminated.

**Violation Description:** All food shall be manufactured, produces, prepared, compounded, packed, transported, kept for sale, and served so as to be pure and free from adulteration and spoilage. Any food is adulterated if it bears or contains any poisonous or deleterious substance that may render it impure or injurious to health. <b>POINTS</b> <b>2</b>	Compliance date not specified Not In Compliance Violation Reference -	<b>Inspector Comments:</b> Observed handwash sink blocked by a trash can.  Maintain the handwash sink readily accessible at all times.

**Violation Description:** Handwashing soap and towels or drying device shall be provided in dispensers; dispensers shall be maintained in good repair. (113953.2) Adequate facilities shall be provided for hand washing. (113953, 113953.1, 114067(f)). Handwashing sink is not separated from a warewashing sink by a 6 inch high metal splashguard or 24 inch separation. (113953) Handwashing sinks shall not be obstructed, inaccessible, used improperly or kept unclean. (113953.1)

**30. FOOD STORAGE; FOOD STORAGE CONTAINERS IDENTIFIED**

<b>POINTS</b> <b>1</b>	Compliance date not specified Not In Compliance Violation Reference - HSC - 114047, 114049, 114051	<b>Inspector Comments:</b> 1. Observed several uncovered containers of food throughout the kitchen and in refrigeration units (sugar, beef, cabbage, cooked refried beans, etc)  Store all food in an approved area and covered with a tight fitting lid to prevent possible contamination.  2. Observed a box of tomatoes and a box of avocados on the edge of the mop sink.  Discontinue storing food on the edge of the mop sink. Properly store all food in an approved dry storage area, food preparation sink or refrigeration unit.

**Violation Description:** Food shall be stored in approved containers and labeled as to contents. Food shall be stored at least 6" above the floor on approved shelving in an approved location to prevent possible contamination. (114047, 114049, 114051, 114053, 114055, 114067(h), 14069 (b))
